Who Can Apply?

4. One application per Larrakia child only.

Successful applicants will be a people who have the motivation and high potential to complete their studies and be committed to succeeding.

Scholarships are being offered for one year within a range of study options








- Tertiary Students: Full Time University Students Up to \$5,000 per calendar year
- TAFE Students: Completing a Diploma Level course. Up to \$1,000 per calendar year
- TAFE Students: Completing a Certificate Level course. Up to \$500 per calendar year
