LDCSCHOLARSHIP PROGRAM (LDCSP)

LDCSP Applicants must:

- Be of Larrakia descent,
- Identify as a Larrakia person, and,
- Be recognised as a Larrakia person within their community.

Successful Applicants will be people who have the motivation and high potential to complete their studies and be committed to succeeding.

Scholarships are being offered for the 2022 academic year across a range of study options based on fulltime study loads:

- Tertiary Students: Completing a Doctorate or Masters level course – upon application.
- Tertiary Students: Completing a Bachelor level course – up to \$2,500 per semester.
- TAFE Students: Completing a Diploma level course – up to \$1,500 per academic year.
- TAFE Students: Completing a Certificate level course – up to \$1000 per course.

Completed applications and supporting documents can be submitted to our Office via email (preferred method), by post, or by hand to Reception. You will be notified when your application is received, approved and/or declined.

In administering the Larrakia Development Corporation Scholarship Program (LDCSP), the LDC will need to collect personal information about you.
